## **REQUEST FOR INFORMATION**

**CASE NUMBER 002 OF 2024: LEMPAA VINCENT SUYIANKA v KENYA LEGISLATORS  
IN THE 2013-2017 AND 2017-2022 TERMS OF OFFICE**

With respect to the above-mentioned arbitration proceedings, information previously supplied to your office, and also available at <https://www.aluochier.co.ke/cases.html>, we acknowledge your functions as provided for in section 34 of the Political Parties Act, 2011, including, among others: (a) to verify and make publicly available the list of all members of political parties, (b) to ensure and verify that no person is a member of more than one political party and notify the IEBC of your findings, (c) to certify that an independent candidate in an election is not a member of any registered political party, and (d) to certify that the names appearing in a party list are the names of the members of the political party presenting the party list. We request that your office provides us with the following information, preferably within the next 21 days, to facilitate arbitral awards made on the basis of evidence:

1. With respect to legislators in the National Assembly, Senate and all 47 county assemblies, the political party membership status of each legislator serving in the 2013-2017 and 2017-2022 terms of office.
2. Notifications made to the IEBC, with respect to legislators in the National Assembly, Senate and all 47 county assemblies, in the 2013-2017 and 2017-2022 terms of office, as concerns whether or not any of them was a member of more than one political party.
3. Pursuant to section 11(8) of the Political Parties Act, 2011, legislators in the National Assembly, Senate and all 47 county assemblies who, after the mergers of political parties in the 2013-2017 and 2017-2022 terms of office, elected to join a political party different from the merged party, or elected to become an independent member, within thirty days of the registration of the merged parties.
4. The above information is requested pursuant to Article 35(1) of the Constitution, providing that every citizen has the right to information held by the State.
